3. Tender Fees of Rs. 500/- may be provided in the shape of DD/FDR/TDR/BG in favour of ICAR – UNIT -PDFMD, Mukteshwar, payable at State Bank of India, Mukteshwar (Branch code No. 2582). This should reach ICAR-DFMD, Mukteshwar office before opening date of Bid as in CPP Portal.
4. **The bid will be opened on CPP Portal. So it is necessary to upload the bids on CPP Portal. Hard Copy of Bid should not be sent to DFMD/ICFMD office.**
